IV. LWI, RCBG Program Overview

a. Purpose of LWI Program

- To serve as the program where floodplain management responsibilities are coordinated across federal, state and local agencies.
- To build a foundation of data, projects, policies, standards and guidance via expert advisors.
- b. Why
 - The Initiative is poised to serve as a model for maximizing the financial, intellectual and government resources to ensure long-term sustainability and safety for all Louisiana residents
- C. Approved Funding Uses
 - · Watershed coordination activities & establishment
 - Public outreach & engagement
 - Floodplain Management
- d. Regional Capacity Building Grant
 - Will last approximately 3 years (has changed due to funding deadlines)
 - The grant is \$400,000 spread over the 3-year period,
 - The RPC is the Region 8 fiscal agent and grant recipient.
 - Grant Timeline:

1. October 31: project inventory list ready Round 1 funding recommendations 2. January 15, 2021: first coalition meeting 3. April 30, 2022: grant funding ends
