# ANNUAL LIST OF OBLIGATED PROJECTS

## FEDERAL FISCAL YEAR 2023

### Background

The [Regional Planning Commission](#) (RPC) for Jefferson, Orleans, Plaquemines, St. Bernard, St. Charles, St. John the Baptist, St. Tammany and Tangipahoa Parishes is a board of local elected officials and citizen members appointed to represent the public on regional planning issues. The board is supported by a staff of professionals with a broad variety of expertise, including transportation, land use, economic development, and environmental planning as well as data management and geographic information systems (GIS).

One of the RPC's primary roles is to house the Metropolitan Planning Organizations (MPO's) for four separate Metropolitan Planning Areas (MPA's): Mandeville-Covington, New Orleans, Slidell, and South Tangipahoa. The RPC's Transportation Policy Committee (TPC) has final decision-making authority over MPO activities, including goal and priority setting, project selection, and programming federal transportation funds. TPC membership consists of all RPC members as well as additional elected officials and representatives from major regional transportation interests.

### About this Report

Infrastructure Investment and Jobs Act of 2021 (IIJA, 23 CFR 450.334), also known as the Bipartisan Infrastructure Law (BIL), requires that MPO's, in coordination with the state and public transportation operators, annually develop a listing of projects for which federal transportation funds were obligated in the preceding fiscal year. An obligation refers to the funding commitment made by the federal grantor agency (Federal Highway Administration (FHWA) or Federal Transit Administration (FTA)) to pay the federal share of a project's capital or operating cost.

The RPC has worked cooperatively with the Louisiana Department of Transportation and Development (DOTD) and the region's transit properties in preparing the Annual Listings for each of the MPO's housed at the RPC for Federal Fiscal Year (FFY) 2023. To aid ease of reference and avoid duplication of efforts this report includes the Listing for each MPO in a single document. The Listings include projects

obligated from October 1, 2022 to September 30, 2023. Highway and transit projects are listed separately. The RPC's Annual List of Obligated projects does not include any projects for which there were no federal funds obligated.

Highway projects are organized by MPA, parish, and state project number. For each project, the following information is provided: a brief description of the project (e.g., pedestrian path, overlay, reconstruction, etc.), project phase for which funds were programmed and obligated (e.g., Right of Way, Construction, etc.), project sponsor, federal funding source, federal funds programmed in the TIP, federal funds obligated during the fiscal year, and federal funding remaining and available for subsequent years. All data provided is for the specific project phase listed (e.g., Right of Way, Construction, etc.) and not for the entire project. All federal obligation amounts for highway projects were obtained from the Federal Transaction List provided by DOTD on October 17, 2023, and reflect obligations made by the state as of that date. The funding amounts provided by DOTD in the Federal Transaction List are included in Appendix A.

Transit projects are organized by MPA and transit provider. For each project, the following information is provided: the project number; the grant award date; a brief description; the federal funding source; the total cost; and the federal cost share. **It should be noted that in FFY 2023 no federal transit funds were obligated in either the Mandeville-Covington or Slidell MPAs.** Federal obligation amounts for transit projects are obtained through ongoing coordination with the region's transit providers and DOTD.

## Relationship to Metropolitan Transportation Plan

The [Metropolitan Transportation Plan](#) (MTP) is the RPC's primary long-term planning document. It describes the region's transportation needs and opportunities, and outlines strategies the RPC and its partners can implement to continually improve the transportation system. MTP 2052 was adopted in August 2022 and directs the RPC to focus on the following Priorities when selecting and developing projects and programs:


- **Safety and Security:** Invest in safe transportation options that will contribute to greater community health by enhancing physical safety and by increasing a sense of security in public places.
- **Sustainability and Resilience:** The transportation system should minimize negative environmental impacts while also enhancing the region's ability to withstand and recover from natural hazards.
- **Equity:** All residents of the regional will accrue benefits from the transportation system, and no person or community will suffer disproportionately from the RPC's transportation decisions.

- **Economic Opportunity:** The transportation system will provide residents with access to employment, facilitate the movement of goods, and connect businesses with customers.
- **Reliability and Connectivity:** Travel times throughout the region will be predictable, and the transportation system will be easy to use.
- **System Preservation and Stewardship:** Emphasis should be placed on maintaining and enhancing the multimodal functionality of existing infrastructure before investing in the addition of new roadway capacity.


Separate MTPs are developed for each of the four MPAs served by the RPC, reflecting their differing transportation systems and overall needs. However, they share the Priorities described above, allowing for a cohesive and coordinated planning process across the entire region.

The RPC tracks the extent to which its projects address each of the MTP's Priorities. Doing so gives staff an overall picture of how the program of projects aligns with the agency's planning goals, and provides accountability by describing the extent to which near-term project implementation supports long-term planning. The percentage of FFY 23 obligated highway projects addressing each MTP Priority in each MPA are described in the figures below, followed by a description of how obligated transit projects address MTP Priorities.


Mandeville-Covington MPA Percent of Obligated Highway Projects Addressing MTP Priorities




New Orleans MPA Percent of Obligated Highway Projects Addressing MTP Priorities


## Relationship to Performance Measures

Federal legislation (23 CFR 490) requires MPOs to track multiple [performance measures](#) that can be used to quantitatively assess the performance of the transportation system over time. The measures evaluate the following key policy areas:


- Motorized Safety
- Non-motorized Safety
- State of Good Repair – Roads
- State of Good Repair – Bridges
- Vehicular Congestion
- Freight Reliability
- Transit Asset Management
  - Rolling Stock
  - Equipment
  - Infrastructure
  - Facilities

The RPC sets targets for each measure and regularly monitors progress towards achieving them. In order to ensure the programs of projects contribute to target achievement, staff tracks the extent to which each project contributes to the performance measure categories. The percentage of FFY 23 obligated projects related to each performance measure in each MPA is described in the figures below, followed by a description of how obligated transit projects address performance measures.


### New Orleans MPA Percent of Obligated Highway Projects Contributing to Federal Performance Measures




### New Orleans MPA Percent of Obligated Highway Projects Contributing to Federal Performance Measures
